

Treasurer/Trustee Search

Adopting 'Advancing Horticulture – Changing Lives' as our mission statement, we provide unique all-round advice and support for horticultural education. Since 1899, through our membership-based organisation, we offer flexible training, educational opportunities, and horticultural experiences throughout the UK. The Charity is open at every level to those who want to learn, whether an experienced gardener or an enthusiastic newcomer, amateur/professional or those looking to change career.

Established in 1899 as the Women's Farm and Garden Association, the Charity has had a significant impact within the world of horticulture. The legacy began before WW1 supporting women in agriculture and horticulture and subsequently continued throughout the 20th century. During the latter part, the Charity developed the Work & Retrain as a Gardener Scheme (WRAGS), a unique practical part-time gardening scheme. This offers members from all walks of life, the opportunity to learn on the job, whilst earning the National Living Wage. This is a widely known and respected training scheme amongst the horticultural community, with many Head Gardeners having started their careers via this route.

Outline

The WFGA is now searching for a new **Treasurer/Trustee**. We are looking for someone to take on the role from December 2022. This follows the stepping down of the current Treasurer/Trustee after successfully fulfilling their tenure.

The WFGA has made significant progress over the past few years, and our strategy remains focused on our original objectives with renewed energy post the pandemic. In this light we are looking for an individual who can offer strong support in the role of Treasurer.

You will have an enthusiasm for helping an organisation with a long history, position itself to deliver its charitable objectives in a contemporary context and to appeal to all walks of horticultural interest.

We are keen to increase the diversity of the Board, therefore other backgrounds are also very welcome, as well as ideally, an interest in horticulture.

Role Description

Summary: The Treasurer has responsibilities for managing and ensuring good financial practice, to oversee the accounts input, risk assessments, charitable monies, and investments. They support the WFGA Chair, Trustees, and office staff by providing financial clarity and decision making. <u>Full details of the role description are attached here.</u>

Terms: These are unremunerated, non-executive positions. Expenses may be claimed in line with the Society's Expenses Policy.

Location: UK based. Subject to the ability to fulfil the practical requirements of the role. Attending meetings in person is desirable but since the pandemic participation online is possible.

Time commitment: The Treasurer role has a time commitment of *up to two hours per week.* There is also the requirement to attend regular Board meetings as mentioned below as well as the AGM where a personal contribution is required in accordance with regulatory requirements. The Board meets 4-5 times a year (including a meeting around the AGM in May), currently via online platforms. There may be additional meetings where necessary. Trustees are expected to prepare for meetings and to be available for occasional consultation by the Chair outside the cycle of meetings.
